COOLING UNIT LIMITED WARRANTY

This cooling unit is warranted (unit only, no freight or labor costs) to be free from defects in material and workmanship under normal use and service for the period of two (2) years from the ATCO America, Inc. INVOICE date. Warranty claims should be made through the original installing dealer. In the event of an emergency or if this is not practical, claims may be made through any reputable RV refrigeration dealer or by contacting ATCO at 1-800-227-3180 for referral to a qualified dealer. Within thirty (30) days of INVOICE date and with prior approval, ATCO America will pay reasonable freight costs (usually UPS) within the 48 contiguous states and reimburse the dealer \$50 of labor if the cooling unit is determined to be defective. **THE INSTALLING RV DEALER MUST OBTAIN AUTHORIZATION FROM ATCO AMERICA, INC. PRIOR TO THE RETURN OF ANY DEFECTIVE COOLING UNIT.**

This warranty extends only to the original purchaser. This warranty shall not apply to any cooling unit that has been subject to misuse, neglect, accident, or abnormal conditions of operation.

Examples of conditions not warranted include but are not limited to the following:

- a) Improper installation (See "Installation" below)
- b) Improper operation--
 - i) Running the cooling unit out of level.
 - ii) Applying a heat source not within the original manufacturer's specifications.
- c) Cooling unit alteration.

To be considered under this warranty, the unit only must be returned to the ATCO America manufacturing facility within the warranty period with the warranty I.D. sticker intact. The manufacturer will test the cooling unit and, if the examination discloses to its satisfaction that the failure is due to a manufacturer's defect and is covered by this warranty, the manufacturer will repair, or at its option, replace the cooling unit only without charge. If the failure has been caused by misuse, neglect, accident, or abnormal operating conditions, all freight, repairs and manufacturer labor will be billed back to the dealer at regular cost. Upon request, an estimate will be provided before work is started. Beyond thirty (30) days from INVOICE date, all freight, dealer installation, and/or repair costs are the responsibility of the customer.

THE FOREGOING WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTY OF MERCHANTABILITY, FITNESS, OR ADEQUACY FOR ANY PARTICULAR PURPOSE OR USE. THERE ARE NO WARRANTIES THAT EXTEND BEYOND THE DESCRIPTION ON THE FACE HEREOF. THE MANUFACTURER SHALL NOT BE LIABLE FOR ANY SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, WHETHER IN CONTRACT, TORT, OR OTHERWISE. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS THAT VARY FROM STATE TO STATE.
